BACKYARD BURNING

To prevent air pollution and eliminate nuisance caused by smoke and odour Council's Backyard Burning Policy has been developed to better control backyard burning especially in closely settled areas

The Backyard Burning Policy applies restrictions to the burning of vegetation in areas within the towns and villages and known urban zonings.

Maps where the restrictions apply are available on Council's

website. Burning of vegetation in these areas is restricted except when exempt. Even though an activity may be exempt residents are still obligated to prevent or minimise pollution and take into account the potential impacts.

Breaches may lead to a penalty infringement notice of up to \$1000.

FREE HELP TO SAVE POWER

More than 50,000 pensioners and families on a lower income have taken advantage of a free home power assessment and power savings kit, as part of the NSW Government's Home Power Savings Program.

Together, they are expected to save around \$11.5 million off household energy bills and 53,500 tonnes of carbon pollution a year.

The Home Power Savings Program is open to NSW residents who have a Centrelink Pensioner Concession,

Low Income Health Care, Veterans' Affairs Pensioner Concession or Veterans' Affairs Repatriation Health card, energy utility hardship customers and social housing tenants. The program aims to reach 220,000 households by 30 June 2013.

Households can get a FREE:

- · Home power assessment by an energy expert which takes about an hour, shows householders how much their appliances cost to run and where savings can be made.
- · Power Savings Kit installed by the energy expert worth around \$200 containing a standby saver power board, energy efficient light globes, a water efficient showerhead, shower timer, draught-proofing strips and more
- · Personal Power Savings Action Plan which lists free and low-cost ways for the household to save power, money and cut carbon pollution.

PROTECT YOUR POOL, PROTECT YOUR KIDS

Summer is here and it is time to check your pool fencing.

Ballina Shire Council, like other local government areas in NSW, requires pools to be fenced to reduce the chances of children drowning

To comply with NSW laws people need to ensure that:

- · Pool fences have no gaps larger than 100mm within or under the fence
- All gates open outwards, self-close and self-latch.
- The fence is clear of objects such as pot plants, BBQ and furniture because children may use them to climb over.
- · Gates or doors are not propped open. Small children are curious.

Responsibilities of pool owners:

- The pool owner is responsible for making sure that their pool is surrounded by a well maintained child-resistant barrier.
- In rented premises, the tenant is responsible for ensuring all gates and doors providing access to the pool are securely closed at all times. Landlords should be notified immediately of damage or hazards.
- All pool owners must display a prescribed resuscitation chart in a prominent position in the immediate vicinity of the pool. Resuscitation charts can be purchased from Council's Customer Service Centre.

If you are installing a pool or buying a property with a pool it's a good idea to ensure all necessary Council inspections have been undertaken.

Don't forget that pool barriers and warning notices are only part of pool safety; the most important aspect is adult supervision of children in and around swimming pools.

The Samuel Morris Foundation, the Swimming Pool and Spa Association of NSW (SPASA) and the Children's Hospital at Westmead (CHW) have developed the Protect Your Pool, Protect Your Kids video. The video is available on the Children's Hospital at Westmead website, to educate pool owners about pool fencing and the common faults.
