#### 1. OBJECTIVE

To provide policy guidelines to assist shire residents who represent Australia.

### 2. POLICY

Council will provide assistance for travel and accommodation expenses incurred by Ballina shire residents who are selected to represent Australia as an individual or as a member of a national team.

#### Guidelines for Selection:

- 1. The individual recipient must be chosen in a team or event that is part of a nationally recognised federation
- 2. The recipient must demonstrate they are a resident of the shire
- 3. The recipient is only entitled to one donation each financial year
- 4. The selection of an entire team will only result in one donation
- 5. The assistance must be provided for expenses that are to be incurred by the recipient as part of their role in representing Australia.

# **Strategies**

The level of assistance to be provided for applicants representing Australia overseas and for applicants representing Australia within Australia, but outside the local government area is provided in the table below (with CPI). Applications will be reported to the Council when required.

#### 3. BACKGROUND

Council recognises that shire residents representing Australia also increases the profile of the Ballina Shire. Council has developed this policy to provide assistance to those individuals to encourage residents to represent Australia and to assist with the promotion of the shire.

In accordance with Section 356 of the Local Government Act, a Council Resolution is required for each donation.

This policy provides a framework to assist Council when considering donations of Council fees for Community Groups.
